Continue on separate sheet and attach as necessary. <p><u>Playtimes</u></p> <ul style="list-style-type: none"> Initial discussion and review of file on roles of Play Leaders and Peer Mediators. Discussed how the process works and rota system. Noted how children were becoming more confident and taking greater responsibility during playtimes. Developing skills in mediation - witnessed this and discussed further with pupils. Benefits also showed that more time was 'freed up' for TAs to encourage and participate in group play. Sports Premium funding from previous year allocated to outdoor gym equipment and being used regularly at playtimes/lunchtimes. This year some allocation for further training for BB and PL/PM, as well as further investment in new play equipment. Saw how children have developed their own sets of rules with peers which they could then implement in games. <p><u>Healthy Eating and well being</u></p> <ul style="list-style-type: none"> Balanced meals on offer – 2 options. Fruit dessert option. Children aware of healthy eating, importance of balanced diet, plenty of water, etc. Discussed system that is in place for staff if they have concerns over well-being/ health of a child in terms of food choices and exercise over a period of time.
