# In the June newsletter we raised awareness of Ofsted's new guidance document for inspectors:



# Inspecting safeguarding in early years, education and skills settings. This document will be statutory from September 2015

There are four separate grades and an overall grade in the new inspection framework:

- **Overall Effectiveness** ٠
- Effectiveness of Leadership and Management
- ٠ Quality of Teaching and Learning, and Assessment
- ٠ Personal Development, Behaviour and Welfare
- ٠ Outcomes

There is also a separate judgement for Early Years Foundation Stage and the 16 - 19 provision.

Do the children, pupils and students in your school have an excellent understanding of how to stay safe online, the dangers of inappropriate use of mobile technology and social networking sites?

Do adults in your school understand the risks from technology and the internet and can they support children in learning how to keep safe online?

The National Education Network (NEN) has adapted the Council on Cyber Security's Critical Security document. The description of each control is accompanied by two sets of questions: one for school network managers and

support staff (operational matters), and one for head teachers and senior leadership teams (policy, strategy, financial).


