Ofsted reveals results of survey on online safety practice at Child Internet Safety Summit, London, 3rd July 2015



Presented by David Brown HMI National Lead for Computing, the survey referenced a discussion on online safety issues with senior leaders, staff, governors and staff across 39 primary schools and 45 Secondary schools' inspections.

Key findings from the data presented:

- 95% of schools had an e-Safety policy
- 74% of pupils/students were aware their school had an e-Safety policy
- More than 25% pupils/students could not recall being taught about online safety in the past twelve months
- A significant majority of schools still do not allow the use of personal devices
- Governors are the weakest link
- Reporting is the weakest area of school practice around online safety

Recommendations on screen time for young children

One of the only established organisations to make recommendations on screen time is the American Academy of Pediatrics (AAP).

- establish "screen-free" zones by making sure there are no televisions, computers or video games in children's bedrooms
- turn off the TV during dinner.
- Children and teens should engage with entertainment media for no more than one or two hours per day, and that should be high-quality content.
- television and other entertainment media should be avoided for infants and children under age 2.

'It is important for kids to spend time on outdoor play, reading, hobbies, and using their imaginations in free play.

A child's brain develops rapidly during these first years, and young children learn best by interacting with people.'

Instagram Privacy Settings

7 Must Know Privacy settings:

1. Change the privacy setting for your photo feed
2. Double-check your Facebook sharing settings
3. Block random followers
4. Edit your profile
5. Wipe photos off Instagram's photo map
6. Delete photos from your photo feed
7. Share photos only with specific Instagram followers

YouTube in 'Safety Mode'

What is YouTube Safety Mode?

Safety mode is a setting which gives users the opportunity to bar mature content.

It is an "opt-in" setting, which means that it won't take effect until you switch it on.

The setting filters search results to remove videos with mature content or videos that have been age restricted, meaning that such content will not show up in video searches, related videos, playlists, shows or movie sections.

While no filtering system is 100 per cent accurate, Webwise recommends that parents of young children enable this feature.
